



Publication pursuant to article 74 §7 of the law of 1st April 2007 on public takeover bids.

Pursuant to article 74§7 of the law of 1st April 2007 on public takeover bids (the “Law”), Ion Beam Applications has received the two declarations referred to as “OPAs” under the terms of article 74§6 of the law, details of which follow:

1. Declaration of joint action dated 30th October 2007

On 30th October 2007, IBA S.A. acknowledged receipt of a declaration of joint action in the names of the following companies:

- S.A. Belgian Anchorage, a company with its head office at Avenue Charles Madoux 13-15, 1160 Bruxelles, the owner of 21.22% of the capital of IBA S.A. (i.e. 5,473,132 shares),
- S.A. Belgian Leverage, a company with its head office at Avenue Charles Madoux 13-15, 1160 Bruxelles, acting in its capacity as a company affiliated to S.A Belgian Anchorage and the owner of 8.92% of the capital of IBA S.A. (i.e. 2,300,000 shares),
- IBA Investments SCRL, a company with its head office at 3 chemin du Cyclotron, 1348 Louvain-la-Neuve, acting in its capacity as a company affiliated to S.A. Belgian Anchorage and the owner of 0.11% of the capital of IBA S.A. (i.e. 29,183 shares).

The declaration of co-operation under the terms of article 74§6 of the law thus related to 7,802,315 securities or 30.25% of the capital of IBA S.A. at this date.

2. Declaration of joint action dated 14th February 2008

On 14th October 2008, IBA S.A. acknowledged receipt of a declaration of joint action in the names of the following companies:

- S.A. Belgian Anchorage, a company with its head office at Avenue Charles Madoux 13-15, 1160 Bruxelles, the owner of 21.22% of the capital of IBA S.A. (i.e. 5,473,132 shares),
- S.A. Belgian Leverage, a company with its head office at Avenue Charles Madoux 13-15, 1160 Bruxelles, acting in its capacity as a company affiliated to S.A Belgian Anchorage and the owner of 8.92% of the capital of IBA S.A. (i.e. 2,300,000 shares),
- IBA Investments SCRL, a company with its head office at 3 chemin du Cyclotron, 1348 Louvain-la-Neuve, acting in its capacity as a company affiliated to S.A. Belgian Anchorage and the owner of 0.11% of the capital of IBA S.A. (i.e. 29,183 shares).



- The Institut National des Radio Eléments (National Radio Elements Institute), an organisation with its head office at Zoning Industriel, Avenue de l'Espérance 1, 6220 Fleurus acting together with the other three declarants and the owner of 3.41% of the capital of IBA S.A. (i.e. 878,660 shares).

The declaration of co-operation under the terms of article 74§6 of the law thus related to 8,680,975 securities or 33.66% of the capital of IBA S.A. at this date.

3. Subsequent events

On 14th May 2008, the date of the company's Ordinary General Meeting, IBA S.A. was able to record that:

- S.A. Belgian Anchorage had taken over all of the securities belonging to S.A. Belgian Leverage which thus increased its holding in IBA to the total sum of 7,773,132 shares, which means that it owns 29.92% of the capital at this date,
- SCRL IBA Investments had increased its holding to a total of 358,692 shares which means that it owns 1.38% of the capital at this date.

Thus, as of 14th May 2008, the declaration of joint action shown in point 1 above related to 8,131,824 securities or 31.30% of the capital of IBA S.A. issued at 14th May 2008.

Thus, as of 14th May 2008, the declaration of joint action shown in point 2 above related to 9,010,484 securities or 34.68% of the capital of IBA S.A. issued at 14th May 2008.
